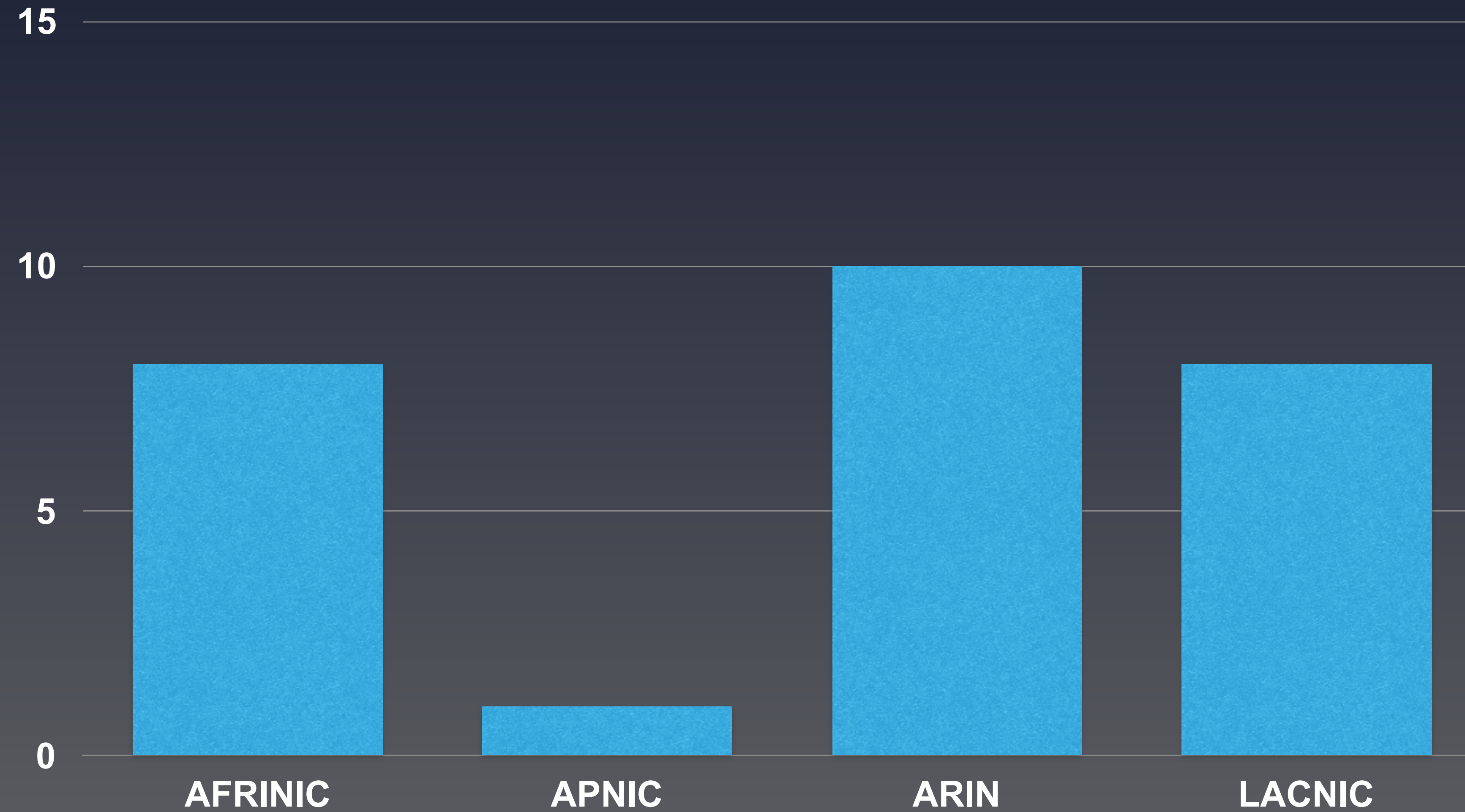


- **Accepted**

- APNIC prop-132, “RPKI ROAs for unallocated and unassigned APNIC address space”



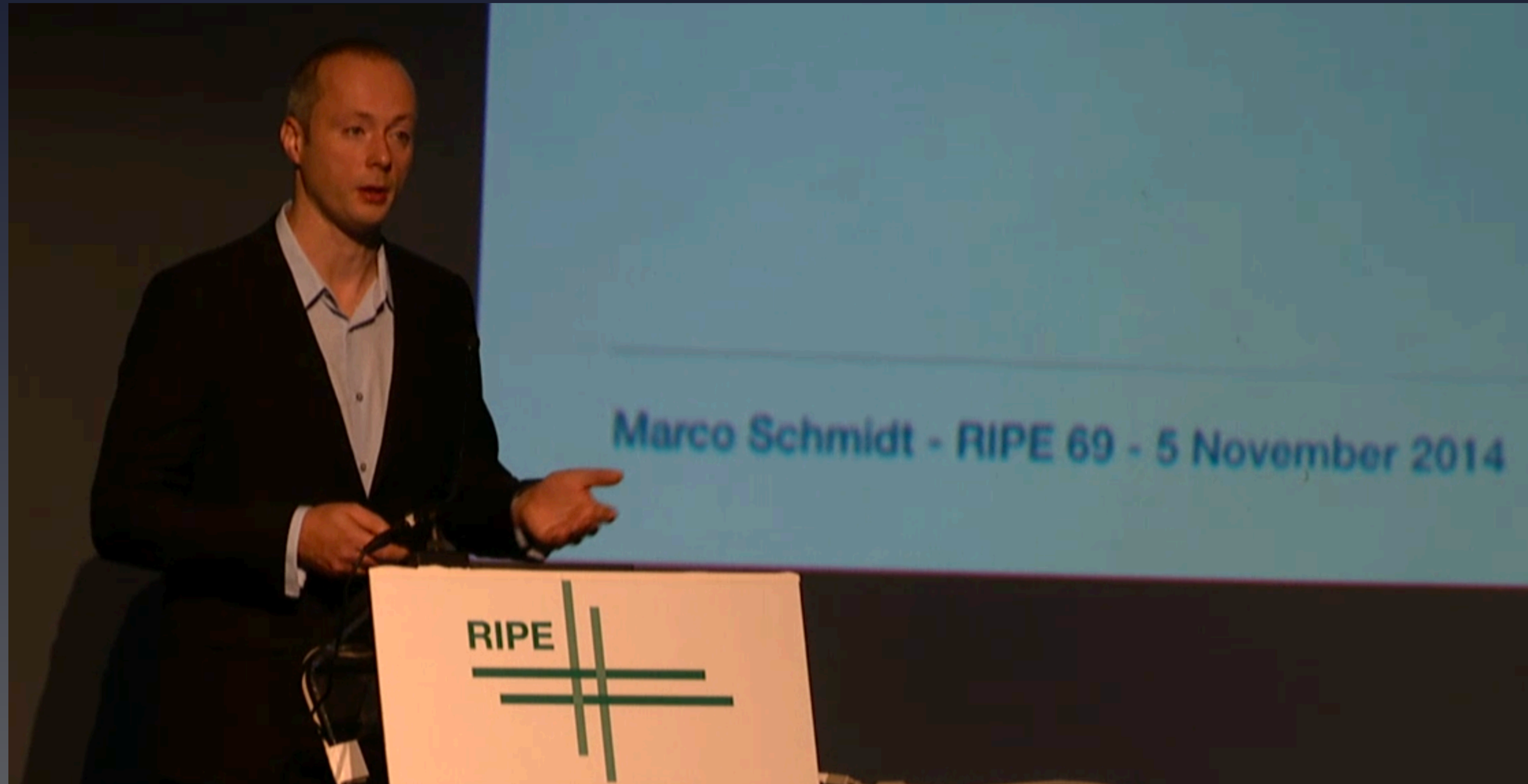

- **Summary of Proposal**
 - The Policy Officer has been doing this job for six years. It's time for a change — both for him and for the Policy Development Office.

Policy Proposal 2019-NCC



- **Arguments supporting the proposal**
 - The new Policy Officer has a solid understanding of the RIPE community and the PDP (Internet Resource Analyst for four years incl. two years as Trainer)
 - Marco will continue to serve the community as Assistant Manager of Registration Services and Policy Development Office
- **Arguments opposing the proposal**
 - The community might miss the previous Policy Officer
 - **Counter-Argument:** There is no evidence for such feelings
